

2019 YEAR IN REVIEW



Promoting Pork in 2019

As we close out the end of the decade, 2019 certainly did not fall short of opportunities for the Ohio Pork Council to promote pork to consumers and educate producers. As the industry continues to evolve, OPC strives for continuous improvement in their promotion and educational efforts.

This year, OPC participated in several consumer-facing events, from the Ohio State Fair, to Ohio State Football games, and more. During these events, our organization was able to educate the public on the qualities of pork and the farmers who raise it. In addition to these events, OPC continues to utilize Family and Consumer Science presentations and Virtual Field Trips as an avenue to reach consumers at a young age.

At the Ohio State Fair, OPC hosted one of the top-visited booths in the Land and Living Building. The OPC Birthing Center, sponsored by Hord Family Farms and Bell Farms Ag, allowed fairgoers to experience the birth of piglets and learn more about a pig's life cycle. To broaden the audience even further, OPC recorded a Facebook Live video of the process. In addition, OPC offered two Virtual Field Trips to Wuebker Farms, allowing fairgoers to experience what a day in the life on a modern pig farm is like.

During football season, OPC promoted pork through their new partnership with Ohio State Athletics. Following the success of the Bacon Vending Machine in 2018, OPC's partnership with Ohio State allowed for an opportunity to display their new Bacon Vending Machine in Ohio Stadium all season long. On social media, OPC achieved one of Ohio State Athletics' highest engaging social giveaways of the year. Before the Ohio State versus Miami University game, OPC members cooked and served free pork loin samples to thousands of Buckeye fans at the National Pork Board's We CareSM trailer. In addition to these efforts, OPC also had digital presence on the endzone scoreboard and on the concourse TVs, reaching the 723,659 fans that were in attendance during the 2019 season.

Thanks to the help of many dedicated volunteers, OPC is able to participate in traditional and new events each year. Our volunteers' time, willingness to participate and passion for promoting pork is truly significant to our industry. Sharing The Story of Real Pig **Farming**

In 2019, the Ohio Pork Council partnered with National Pork Board and the National Pork Producers Council to broaden their reach to consumers.

Over the summer, OPC worked with NPB and NPPC to host nine Registered Dietitians from across the country for a behind-thescenes look at some of Ohio's modern pig farms. During their time in Ohio, attendees had the opportunity to learn about the pork production process from birth to market at Heimerl Farms. Throughout the day, the dietitians learned about biosecurity practices, the farrowing process, proper nutrition, nutrient management, technology and much more. After spending an entire day touring farms, attendees spent their final day in Ohio at the Columbus Culinary Institute to learn about the pork fabrication process and put their cooking skills to the test.

In addition to the farm tour, OPC worked with NPB to identify three unique Ohio pig farmer stories to capture on video and share across social media platforms. In July, NPB travelled to Ohio to produce videos of Jack and John Sommers, Gracee Workman and Paul Kalmbach Jr. – all of which will help share the stories of Real Pig Farmers of America – one of NPB's social media campaigns that will continue in 2020.

Utilizing different communication techniques to reach all facets of consumers is important to OPC – and national efforts like these help our organization achieve those goals.









Pork in the Classroom

Educating consumers from a young age remains a top priority for the Ohio Pork Council. Through OPC's Virtual Field Trip and Family and Consumer Science programs, our organization is not only able to educate students on modern farming practices, but we're also able to help students make informed decisions at the grocery store and in their kitchen.

During the 2019 calendar year, the OPC Virtual Field Trip program celebrated its fifth anniversary and reached 2,068 students in 99 classrooms. Throughout the year, OPC was able to take elementary, middle and high school students from across the state on a virtual trip to an Ohio-based pig farm from the comfort of their own classroom.

Through the Family and Consumer Science program, OPC presenters reached 11,210 students in 608 classes on 119 presentation days during the 2019 calendar year. Each year, teachers look forward to welcoming presenters into their classrooms to facilitate lessons about food and agriculture.



Thank you to all of the dedicated farmers who participate in these programs and help generate positive conversations about Ohio's pork industry! OPC looks forward to continuing these popular programs in 2020.



OPC Joins The Ohio Agricultural Conservation Initiative

In November, Governor Mike DeWine outlined his framework for the use of H2Ohio funds to improve Ohio's water quality. The Ohio Agriculture Conservation Initiative (OACI), of which OPC is a member, will serve as an integral partner in this initiative. This is, in large part, recognition of our commitment to lead in developing and deploying solutions that result in meaningful water quality improvements.

We all agree that Ohio's water is one of our greatest treasures and assets, and that it is our collective responsibility to protect it. That is why OACI was created. This innovative, collaborative effort of the agricultural, conservation, environmental and research communities is working to improve water quality by establishing a baseline understanding of current conservation and nutrient management efforts while building farmer participation in a new voluntary certification program.

We are proud that OACI will work with the H2Ohio program - which will ensure funds are distributed to farmers who demonstrate a commitment to continuous improvement through implementation of science-based practices that contribute toward healthier waterways.

Equally, we are proud to partner with trusted experts such as The Ohio State University College of Food, Agricultural, and Environmental Sciences, and the National Center for Water Quality Research at Heidelberg University, and we thank them for their support. We look forward to working with additional academic and scientific partners in the future.

As this partnership progresses, we will continue to communicate with you about accessing H2Ohio funds, and how OACI will measure improvements in on-farm water quality efforts and adoptions of field-specific nutrient best management practices.

I. Introduction.

The first year of the 133rd General Assembly is coming to a close. Please find a review of relevant legislative efforts throughout 2019. Bricker & Eckler looks forward to working with the Ohio Pork Council on its strategic priorities in 2019.

II. 2019 Legislative & Regulatory Overview. In 2019, legislative action occurred around the water quality issue following the pattern of 2018. The biennial budget, H.B. 166, created a new initiative backed with state funding, H2Ohio. Many actions

A. H2Ohio. The biennial budget, H.B. 166, allocated \$172 million to the H2Ohio water quality plan. This funding mechanism also authorizes the Controlling Board in Fiscal Year 2021 to increase or appropriate dollars to support water protections vision and strategy. The Lake Erie Commission will coordinate with state agencies such as the Environmental Protection Agency, Department of Natural Resources, and Department of Agriculture to submit an annual report to the governor and legislature on H2Ohio spending and funds for each fiscal year.

After funding H2Ohio, Governor DeWine pivoted to establishing the strategy and implementation for the program. On November 14, 2019, Governor DeWine announced specifics of his H2Ohio plan. H2Ohio funds will help farmers implement a series of ten phosphorus reduction strategies. Implementation will begin in the Maumee watershed and eventually spread statewide. Participating farmers participate in a certification process in order to receive funds to assist in the implementation of the phosphorus reduction strategies. Utilization of the ten strategies is not a mandate.

The ten phosphorus reduction strategies are: soil testing, variable rate fertilization, subsurface nutrient application, manure incorporation, conservation crop rotation, cover crops, drainage water management, two-stage ditch construction, edge of field buffers, and new wetlands in targeted areas.

In addition to reducing phosphorus run off, wetlands shall be established to assist in absorbing pollutants. H2Ohio also will address failing home septic systems and possible lead contamination in high-risk daycare centers and schools. The Ohio EPA will provide funds for infrastructure projects in disadvantaged communities to address these issues.

On November 22, 2019, ODNR unveiled six pending wetland projects to be created or rehabilitated through the H2Ohio water quality fund. These projects include Oak Openings Preserve in Lucas County, Sandusky Redhorse Bend in Sandusky County, Maumee Bay State Park Wetland in Lucas County, Grassy Island and Cullen Park Wetland restoration project in Lucas County, and Forder Bridge in Paulding County. On November 26, 2019, Ohio EPA announced an H2Ohio-backed project in Pomeroy, Ohio. Subsequently on December 6, 2019, Ohio EPA announced an infrastructure project in Williams County for the area of Kunkle. This project is also being funded by H2Ohio funds. Several other H2Ohio-backed projects are expected to be announced in the coming weeks.

The House and Senate introduced separate bills also relating to water quality issues. The House introduced H.B. 7. Representative Ghanbari (R- Perrysburg) and Representative Patterson (D- Jefferson) are sponsors of House Bill 7, which creates the H2Ohio Trust fund and the H2Ohio Advisory Council to disburse dollars from the trust fund for water quality programs. H.B. 7 also creates the H2Ohio Endowment Board, which allows the fund to accept donations, land, title to land and federal dollars. H.B. 7 passed the Ohio House on June 20, 2019. The bill received one hearing in Senate Finance Committee on October 22, 2019.

The Senate's bill, S.B. 2, is sponsored by Senator Peterson (R- Sabina) and Senator Dolan (R- Cleveland). S.B. 2 creates the Statewide Watershed Planning and Management Program under the administration of the Director of Agriculture. This program requires that the Director categorize watersheds and appoint at least one watershed planning and management

coordinator to each categorized watershed. In addition, S.B. 2 requires the Department of Agriculture to establish a pilot program that assists farmers, agricultural retailers, and soil and water conversation districts in reducing phosphorus and dissolved reactive phosphorous in a watershed to be determined by the Department. S.B. 2 passed the Ohio Senate on June 12, 2019. Currently, S.B. 2 has received two hearings in the House Energy and Natural Resources Committee.

Debate continues on whether both bills should pass separately or one of the bills should be amended into the other bill. These two bills continue to cause strife between the two chambers.

B. New Farmer Tax Credit. Representative Manchester (R- Lakeview) and Representative Patterson (D- Jefferson) introduced House Bill 183 on April 3, 2019. H.B. 183 creates income tax credits for beginning farmers who participate in a financial management program. The bill also provides nonrefundable income tax credits for individuals and for businesses that sell or rent agricultural land, livestock, facilities, or equipment to beginning farmers. The Director of Agriculture will certify individuals as beginning farmers. On October 29, 2019, the House Agriculture Committee accepted a substitute bill that eliminates language that prohibited a person to receive the tax credit if he purchased the land or rented the land from a family member. The substitute bill also includes stops the tax credit after December 31, 2021. Sub. H.B. 183 passed out of House Agriculture and Rural Development Committee on November 19, 2019. The bill currently awaits a House Floor vote. H.B. 183 also has companion legislation in the Senate, S.B. 159. S.B. 159 has not received a hearing in the Senate Agriculture and Natural Resources committee. Therefore, H.B. 183 is likely to be the vehicle for this policy to become law.

C. Nuisance Abatement. The House amended H.B. 166 to expand the complete defense in civil actions for nuisances involving agricultural activities. This amendment was a priority for many farm trade associations. Ohio's recent water quality initiatives have required farmers to act differently than before and there is a prevalent concern for frivolous lawsuits based upon these new activities.

The amendment language expanded the complete defense to include agricultural activities that were conducted on land devoted exclusively to agriculture use in accordance with the law and agricultural activities conducted by a person pursuant to a lease agreement. Agriculture activities is now defined as agriculture practices, including agriculturalrelated practices. These activities include the following: cultivation of crops or changing crop rotation; raising of livestock or changing the species of livestock raising; entering into and operating under a livestock contract; the storage and application of commercial fertilizer; the storage and application of pesticides and other chemicals commonly used in agriculture; an expansion, contraction or change in operations; and any agriculture practice that is acceptable by local custom. Also, the plaintiff in a nuisance action is no longer to be specified as an individual who is not engaged in agricultural production.

On July 18, 2019, Governor DeWine signed H.B. 166 into law. This specific provision was effective on October 17, 2019.

III. Conclusion.

Bricker and Eckler looks forward to working with the Ohio Pork Council in 2020. We anticipate additional announcements on the H2Ohio program and the process for farmers to get involved.

Becoming a Swientist

Transmission of influenza A viruses (IAV) between pigs and people has been reported periodically worldwide but has recently received considerable publicity - with 466 documented cases of swine-origin IAV in people in the United States since 2011. The H3N2v outbreak of 2012 became the largest swine-to-human influenza outbreak since the 2009 H1N1 pandemic. The investigations into the reported human cases of H3N2v during the 2012 outbreak revealed that 95% of the cases reported direct or indirect contact with swine, and 93% of the cases recounted attendance at an agricultural fair within four days of illness onset. The majority of 2012 H3N2v cases were youth exhibitors and others in close contact with pigs at the fairs, and with nearly 150 million people attending agricultural fairs each year, exhibition swine have become the public face of the pork industry.

The Ohio State University is unique in the ability to study these issues; an active IAV surveillance program was established in 2009 to monitor the pigs at agricultural fairs and stock shows. The results of this ongoing project indicate that, on an annual basis, approximately 25% of Ohio fairs have pigs shedding IAV by the conclusion of the fair. Within those fairs where there are pigs shedding IAV, the estimated prevalence of IAV infection in the swine population is less than 66%, indicating the viral burden in these settings is high. Furthermore,

the majority of IAV infections among swine at the fairs are subclinical, making it difficult to identify and remove infected animals.

In 2016, The Ohio State University partnered with OH-PIGS, The Ohio Summer Show Circuit. to conduct influenza surveillance at swine jackpot shows in effort to gain insight into the origins of influenza A viruses circulating in the swine at fairs. Becoming immersed in show pig culture gave the Ohio State investigators a new perspective on the lack of infectious disease education in current youth agriculture programming.

To address those gaps, The Ohio State team launched their Becoming a Swientist program to educate youth raising swine about infectious diseases in pigs and people, deliver prevention messages to keep people and animals safe and healthy, and strengthen networks among human, animal health and agricultural communities across rural Ohio. In 2019, Becoming a Swientist hands-on trainings were conducted with youth attending 4-H/FFA conferences such as Ohio 4-H Conference, Ohio 4-H Junior Swine Day, OH-Pigs Jackpot Circuit kick-off weekend, and various 4-H club and FFA chapter visits. Example activity topics included: proper vaccine usage, cleaning and disinfection, hand washing, disease traceability, and how infectious agents spread.

Youth involved in the OH-PIGS show circuit had additional opportunities to participate in the Becoming a Swientist program. Those youth competed in a health habits selfie contest, where participants submitted over 130 photos



demonstrating how they implement biosecurity practices on their farms or at shows. In addition, youth involved in the program competed in a biosecurity poster contest and displayed their work at the Ohio State Fair.

Through new and strengthened partnerships with other organizations, Ohio State's Becoming a Swientist programming has expanded beyond Ohio. Collaboration with the National Junior Swine Association has extended Ohio State's reach to national level swine shows. As an example, youth exhibitors representing 23 states participated in Becoming a Swientist activities at The Exposition in June 2019. Each day of the show included a new hands-on activity to engage youth and strengthen knowledge. Additionally, Ohio State personnel collaborated with National Pork Board to conduct biosecurity training sessions at the 2019 National Pork Industry Conference in Wisconsin as an effort to provide education to youth engaged with the commercial side of the pork industry.

Over the past several years, the team at The Ohio State University has grown to include leaders who are committed to educating youth participating in agricultural organizations on the prevention, control, public and animal health impacts of influenza transmission between species.







Jim Heimerl of Heimerl Farms

The Ohio Pork Industry Excellence Award, sponsored by Elanco Animal Health, is presented to a pork farmer, or farm family, for their willingness to go above-and-beyond to donate time, money and talents on behalf of the industry. This year, the Ohio Pork Council is pleased to recognize Jim Heimerl of Heimerl Farms for all of his contributions to the pork industry – both at the state and national level.

Heimerl Farms began in 1975 as part of an FFA project. Today, Jim's family farm sells 800,000 pigs per year. Alongside his wife, sons and daughter-in-law, Jim strives to uphold the mission of their farm through strong values, superior animal care, environmental stewardship and good community relations. In addition to their daily roles on the farm, Jim and the Heimerl family dedicate time to educating community members about agriculture and the environment through farm tours and events. Over the years, Jim and his family have provided several state policy makers with on-farm tours and education about Ohio's pork industry.

Known by many as an active member in agriculture, Jim has played pivotal roles in the pork industry over the years, serving as President of the National Pork Producers Council from 2018-2019, and President of the Ohio Pork Council in 2013.

During his time with NPPC, Jim was an instrumental leader of the Farm Bill Taskforce, in which pork producers successfully requested and received funding for more robust animal disease preparedness and management programs, including a vaccine bank to address the risk of Foot and Mouth Disease. What's more, under Jim's leadership, NPPC reached many significant accomplishments – from the USDA's purchase of \$558 million of pork for food banks, to moving trade deals forward with Canada, Argentina, Mexico and Columbia.



As a member of the Ohio Pork Council board of directors, Jim was part of the executive committee when the agreement between Ohio's agricultural leaders and the Humane Society of the United States (HSUS) was made in 2010 – ultimately preserving the long-term viability of Ohio's pork industry. Reflecting on his time as President of the Ohio Pork Council, one of Jim's strongest attributes was his willingness to bring the thoughts of fellow pork producers to the attention of OPC's board.

In addition to his leadership within the pork industry, Jim also served a term on the Ohio Soybean Association board of directors and is currently a 30 year-member of the Hartford Independent Fair Board, where he has played an essential role in the growth and development of the fair.

Whether he's advocating for agriculture on Capitol Hill, volunteering at an Ohio Pork Council event, or working on his family farm, Jim Heimerl is always eager to gain insights from fellow pork producers, and passionate about using those insights to make a difference within the industry.





Tony Nye

Every year, the Ohio Pork Council presents the Ohio Pork Industry Service Award to an individual who exemplifies outstanding service to the swine industry. This individual exceeds volunteer expectations and is willing to support the pork industry in various ways. This year, the Ohio Pork Council is pleased to congratulate Tony Nye with the 2019 Ohio Pork Industry Service Award.

Tony currently serves as the Agriculture and Natural Resources Educator for Ohio State University Extension in Clinton County, where he has been actively involved for the past 31 years. In 1990, Tony, along with other extension educators from around Ohio, founded the Extension Swine Educator Team, in which he has been highly involved in pork production systems; nutrition and health; Pork Quality Assurance; Swine Mortality Composting; and Ventilation and Trucker Quality Assurance. In the past 10 years, Tony has certified over 1,495 commercial producers and youth in Pork Quality Assurance, over 40 livestock haulers in Transport Quality Assurance, and 120 commercial producers in Mortality Composting.

Sixteen years after starting his profession with Ohio State University Extension, in 2006, Tony began serving as the State Coordinator for Small Farm Programs



- in which he has provided a greater understanding of production practices, economics of land use, assessment of personal and natural resources, and marketing alternatives to pork producers across the state.

In addition to his involvement with Ohio State University Extension, Tony has remained active within the Ohio Pork Council, Ohio State Fair, and other industrywide events. From 1985-2018. Tony served as an Assistant Swine Superintendent at the Ohio State Fair, and was just recently inducted into the Ohio State Fair Swine Hall of Fame in 2019.
